24) The trustees may jointly or individually negotiate or arrange any loan/ borrowing or financial assistance or credit for the purpose of the trust from any bank or financial institution or private party or parties with or without security and can mortgage any of the asset or property of the trust for that purpose and likewise can stand guarantee or security for any such loan or credit facility taken by other party or body corporate.

25) The trust hereby created shall be irrevocable.

26) In the event of dissolution of the Trust, the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. The assets left if any, shall be disbursed to other Trusts or Associations having similar objectives after obtaining previous approval of Commissioner of Income-tax and in no event it shall be distributed in any manner, to any of the Board of Trustees or their relatives or related concerns.
